QUESTION ONE (30 MARKS)

THE ROLE OF PROCUREMENT IN SHAPING NACOL TO A WORLD CLASS ORGANIZATION

In the running of today's competitive business, procurement plays the critical role of acquiring goods or services required for production or running of the business. The goods and services are acquired from external sources. In brief, the procurement process involves requesting bids from vendors, selecting the best option, and then negotiating terms and conditions. At Nacol Limited, a company that specializes in the manufacture of Fast Moving Consumer Goods, procurement is a critical part of the strategic team within the organization, as it encompasses all activities involved in helping ensure profitability and growth of the company. Procurement department ensures that there is continuous supply of materials and services needed to produce products or deliver services. The main functions of procurement include obtaining supplies at the best possible price, ensuring that quality standards are met at all times and to ensure materials required are delivered within the stipulated timelines to ensure competitiveness of the products in the market.

As a growing organization, Nacol uses different types of procurement methods to deliver the best value to the organization however each procurement method has its own set of challenges. The most common procurement methods used by Nacol include: direct purchase, competitive bidding, Request for Proposal (RFP), and Request for Quotation (RFQ) among many others. All the procurement methods are therefore evaluated before any is deployed. Procurement is a critical part of the business and can have a significant impact on the overall performance of the business if well executed. There are many different procurement strategies that can be employed, and the most effective strategy will vary depending on the specific industry. There are some general principles however that all successful procurement strategies should follow. To ensure compliance with the procurement processes, Nacol has developed several steps used in sourcing that have been named the Strategic Steps of sourcing which is always used when sourcing for goods and services. The Nacol procurement is centralized in order to leverage on the size of the organization.

The purchasing team sits at the Head office and sources materials for all the plants. First, Nacol has aligned procurement with the overall strategy of the company. The procurement strategy supports the company's business objectives and help to achieve its strategic goals. Second, the procurement function is integrated into the rest of the organization. The procurement team works closely with other departments within the company, such as marketing, sales, and operations, to ensure that there is always early procurement involvement in the purchasing needs of the company. Third, procurement at Nacol is proactive rather than reactive. The procurers anticipate future needs and trends and take steps to ensure that they are prepared for them. The success of procurement at Nacol depends on the strong relationships with suppliers. The procurement team has built strong relationship with their suppliers to ensure J-I-T delivery, ensured quality, and agreed upon quality among several other critical things.

Case Study Questions:

- a) For the Procurement Department to assist NACOL in developing a world class organization, Mark who is the procurement Director wants to develop a Procurement Standard Operating Procedure that the organization must follow in future in the purchase of goods and services. Mark has therefore formed a task force to assist in streamlining the procurement process. Explain in details, discuss the steps that NACOL Corporation can take to streamline its procurement process. (6 Marks)
- d) In making all intended changes in adopting a new procurement processes, Mark is likely to face some challenges. Discuss three potential challenges that NACOL might experience in transitioning from her current procurement process to an e-procurement system, and how can NACOL Corporation address them.

- e) To transition from the current procurement process to the proposed procurement organization, NACOL must carry out performance measurement. Discuss three Procurement performance indicators that Mark Corporation track to measure the success of the procurement function that he is leading. (6 Marks)

- b) Simon Andrew the Operations Director with Big Mark Corporation has a group of interns newly onboarded in the organization. The interns are to be attached to the Procurement Department for three weeks to appreciate the role of procurement in the organization. Simon wants to explain the principles the procurement team is using in the purchase of goods and services. Explain at least five Principles of Purchasing that Simon needs to discuss with the interns.

- Anne Marrie, the new Procurement Manager at Amazoan Corporation is aware of un ethical dealings that take place during purchasing of goods and services. - d) Alice the Continuous Improvement Lead in the Supply chain department is well aware of the impact that Quality has on the finished products of Power It, a company that manufacturers Fast Moving Consumer Goods. Describe the key considerations related to quality levels that Alice should focus on during her Quality Circles. (5 Marks)

- a) PMC Enterprises has recently experienced a disruption in the management of her supply chains due emerging trends in purchasing. The Operations Manager is preparing to brief the CEO on the steps she is taking to mitigate on this supply chain disruptions. Explain FIVE mitigating strategies for countering emerging issues in purchasing that the Operations Director should list down for briefing the CEO (5 Marks)
- b) The newly appointed CEO of Mono Motapa PLC believes that a Centralized Purchase Organization Structure can deliver more value than other forms of Purchasing organization structure. He wants to convince the Board of the company on the need to adopt a centralized purchase organization structure. As the Director of Supply Chain Management whom the CEO has tasked to develop the Board paper, discuss FIVE reasons the CEO needs to convince the Board to adopt a centralized purchasing organization structure as opposed to other purchase organization structures (5 Marks)

- c) John has developed a policy on Supplier Development and is keen on deploying the policy.
